Section 19(a) Notice to Shareholders of the Madison Covered Call & Equity Income Fund

The Madison Covered Call & Equity Income Fund (the "Fund") has declared a quarterly distribution of \$0.14 per share to shareholders of record as of March 28, 2025, with the distribution paid on March 31, 2025.

Due to various regulations on investments in mutual funds, certain distributions made during the calendar year must be identified as "Return of Capital" for accounting purposes until the end of the fiscal year when the tax code permits a "re-categorization" of income or gains. As a result, when distributions are made during the year from the Fund, shareholders receive a so-called "19(a) Notice" in the mail identifying the distribution as "Return of Capital."

This information is sent to you for informational purposes only and is an estimate of the sources of distribution. It is not determinative of the tax character of the Fund's distributions for the 2025 calendar year. This distribution and the cumulative year-to-date distributions are considered mostly a return of capital on a book basis. Note that both short-term and long-term capital gains are not considered income for book purposes. The following table sets forth an estimate of the sources of the Fund's distribution and its cumulative distributions paid this fiscal year to date. Amounts are expressed on a per share basis and as a percentage of the distribution amount, and its cumulative distributions paid this fiscal year to date (excluding any Section 855 spillover distribution paid and end of fiscal year tax adjustments) for tax purposes.
